New Mexico Art Education Association (NMAEA)

The New Mexico Art Education Association (NMAEA) is a 501c3 non-profit organization created by art educators for art educators from across our state of New Mexico. NMAEA is an affiliate of the National Art Education Association (NAEA).

Mission Statement

The mission of the New Mexico Art Education Association (NMAEA) is to advance and enhance quality art education within our state by offering professional development, leadership, and service opportunities for its members.

Vision Statement

The NMAEA will strive to unify, encourage, and support art educators through professional development, leadership, service, and research to support personal and professional growth. We will promote quality instruction in visual arts education by certified art teachers; encourage research in art education; hold public discussions; sponsor workshops and conferences; offer grant opportunities; publish articles and reports; and work with other related agencies in support of visual arts education in our state and across the country.

Preamble to the Constitution

The New Mexico Art Education Association (NMAEA), through this constitution, sets forth the means by which those responsible for art education in New Mexico may provide the experiences in art essential to meet the varied interests, needs, and abilities of New Mexicans.

As art educators, we believe in the inherent right of every individual to have full and free opportunity to explore, develop, and broaden one's creative capabilities in the field of the arts. In a highly technological society such as ours, the arts serve as a humanizing force, give dignity and a sense of worth to the individual. The arts provide the means by which aesthetic quality may be recognized and developed in our multicultural state. They also provide the background training that is essential to enter innumerable careers.

It is our purpose to promote and maintain the highest possible quality arts instruction throughout the state of New Mexico.

It shall be our intent to communicate our beliefs to the school administrators, organized teaching professionals, and the community to strengthen the position of art as a necessary discipline in the school curriculum.

Article I – Name

The organization shall be known as the New Mexico Art Education Association (NMAEA).

Article II – Purposes

The NMAEA shall be a non-profit corporation organized and operated exclusively for educational, literary, and scientific purposes (within the meaning of Section 501(c)3 of the Internal Revenue Code of 1954 amended) primarily by assisting the advancement of the instructional program in the schools in the State of New Mexico, by developing and supporting a program of art education and research, and by furthering the evaluation and utilization of art curricula and other instructional media.

Section 1: To develop and promote standards of instruction in art and to make recommendations for the provision of adequate instructional materials, equipment, and school plant facilities which will create and maintain optimum learning conditions in art.

Section 2: To develop and promote standards of preparation for teachers of art in the state of New Mexico in the several levels of education.

Section 3: To cooperate with other professional education associations such as The National Art Education Association, The Public Education Department, and other groups or organizations interested in promoting the arts, (such as The Alliance for Arts Education, the Association for Supervision and Curriculum Development, etc.).

Section 4: To enable members to speak with a common voice on matters pertaining to the profession and to present their common interests before appropriate governing agencies.

Section 5: To encourage and promote research and publications significant to art education in particular and education in general.

Section 6: To explore the common factors and the unique aspects in the arts of the various cultures and to understand and appreciate the role art has played in all cultures as man has developed.

Article III – Membership

Individuals interested in or engaged in activities concerned with, or related to art, art education, or education are eligible for membership.

Article IV – Organization and Government

Section 1: The NMAEA shall be organized to include the membership and the Council which is composed of the Board of Directors and Advisory Council.

Section 2: The Board of Directors. The Board of Directors (BOD) of the NMAEA shall be the Executive Officers, including President, President-Elect, Current Past President, Secretary, Treasurer, Divisions Director and Membership Director.

A simple majority of the members of the BOD shall constitute a quorum. The BOD shall be the executive authority of the association. All members of the BOD, with the exception of the ex-officio members, shall have voting privileges.

The President is a non-voting member of the BOD. The president may only vote in the event of a tie.

Section 3: Council. The Council shall be composed of the Board of Directors and the Advisory Council which includes the Communications Chair, the Conference Chair, the Scholastic Art Chair, the Awards Chair, the Resource Development Chair, the Youth Art Month Chair, the Equity, Diversity, and Inclusion Chair, and the State Department Visual Arts Advisor.

Section 4: Terms of Office. The term of office of the officers shall be for two years with the exception of the three year sequence of the President-Elect, the President, and the Current Past President whose terms will be for one year each.

Article V – Elections and Appointments

Section 1: Elections. Elections for the President-Elect will be held annually. Elections for Treasurer, Membership Director, shall be held in even numbered years. Elections for the Secretary, and the Division Director shall be held in odd numbered years. Candidates for BOD must be members in good standing who have held active membership in the Association for a minimum two consecutive years. A majority of the votes cast by the membership is required for election.

Section 2: Nominating Committee. At six months prior to an election, the President

shall appoint an ad hoc nominating committee composed of one member at large, the President-Elect, and one representative of the Advisory Council. The committee shall prepare a slate of candidates for each position to be filled. The slate shall be presented to the BOD for approval and to the membership for a vote.

Section 3: Vacancies. In the event of a vacancy, in any elected office of the NMAEA, the President may appoint with the approval of the BOD, an interim officer to fill the vacancy until the next election cycle can take place. In the event of a vacancy in the position of President, the President-Elect shall assume the duties of the vacated position and appoint an interim President-Elect with approval of the BOD.

Section 4: Voting. All active members of NMAEA shall be eligible to vote. The elections will be held during the month of the fall conference of every year. Proxy voting will be allowed for members unable to attend the fall conference.

Section 5: The newly elected officers shall assume office on January 1st following elections.

Article VI – Meetings

The full Council will meet at least quarterly within the year, with one of the meetings occurring at the fall conference. Special meetings may be called by the President.

Article VII – Standing Committees

Section 1: Standing Committees. The NMAEA shall have the following Standing Committees: Divisions, Scholastic Art Awards, Resource Development, Awards, Communications, Conference, Youth Art Month, Finance, Equity Diversity and Inclusion, and Membership.

Section 2: Special Committees. Special Committees may be appointed by the President and/or the BOD to undertake special assignments. Special Committees shall be appointed on an ad hoc basis and shall serve no longer than the term for which they were appointed.

Article VIII – Income and Benefits

No part of the net earnings of the NMAEA shall inure to the benefit of any

member, sponsor, donor, creator, trustee, officer, employee, or without limitation, any other private individual, or to the benefit of any corporation, any private individual or any substantial part of the activities of which is carrying on propaganda or otherwise attempting to influence legislation; provided, this shall not prevent payment of reasonable compensation for service actually rendered to or for the Association in its purposes.

Upon dissolution, all of the assets of the NMAEA shall be turned over to such non-profit, tax- exempt, charitable, scientific, or educational organization exempt from federal income taxation under Section 501 (c) (3) of the Internal Revenue Code of 1954 or any successor provision thereto as the final Board of Directors of the NMAEA shall select.

The NMAEA shall not divert any part of its income or corpus to any member, sponsor, donor, creator, trustee, officer, or employee; by lending any part of its income or corpus without the receipt of adequate security and a reasonable rate of interest; by paying any compensation in excess of reasonable allowance for salaries, or other compensation for personal services actually rendered; by making any purchase or security of other property for more than adequate consideration for money or money's worth; or by engaging in any other transaction which either directly or indirectly results in such diversion of its income or corpus. The NMAEA shall not use any income for purposes other than the objects herein before set forth and shall invest income as per established policy. The NMAEA shall not act in any way or engage in any activity, which might affect its right to full tax deduction of the members' contributions to the Association. The NMAEA shall be so operated as to be entitled to, and receive all tax exemptions, federal and local, which from time to time be granted to charitable, scientific, or educational associations of foundations.

Article IX – Amendments

Amendments to the constitution shall be voted on by the membership. A simple majority of the votes cast is required for passage of an amendment. All proposals for amendment shall be reviewed by the BOD.

Bylaws

Article I – Duties of the Board of Directors

Section 1: President.

- A. Shall act on behalf of the NMAEA in an official capacity and shall preside at meetings of the Board of Directors and Council and all general meetings.
- B. Shall appoint special committees, chairpersons, and parliamentarian as necessary; shall serve as an ex-officio member of all committees
- C. Shall coordinate and delegate responsibilities to BOD, Advisory Council and committees.
- D. Shall represent the NMAEA, or appoint a representative, in the New Mexico Alliance for Arts Education and all other appropriate groups and/or associations which seek to support the advancement of art education in New Mexico
- E. Shall serve as New Mexico Delegate to both NAEA Delegates Assembly and Western Regional summer meeting. In the event that the President cannot attend, the President can appoint a representative of the BOD to attend in his or her place.
- F. Shall be responsible for signing all legal documents and contracts.

Section 2: Current Past President.

- A. Shall serve as an advisor to the President and shall have such other duties as may be assigned by the President or BOD.
- B. Shall serve as Chair and voting member of the Finance Committee.
- C. Shall assume other duties as determined by the President.

Section 3: President - Elect.

- A. Shall ascend to the Presidency automatically and shall assume the duties of the

President in the event of the disability, absence, or resignation of the President.

B. Shall serve as Nominating Committee Chair.

C. Shall assume other duties as determined by the President.

Section 4: The Secretary.

A. Shall record minutes of all meetings and make available copies of the drafted minutes within 2 weeks to all Council members. Specific meetings to be included: BOD Meetings, Council Meetings and NMAEA Annual Membership Business Meeting.

B. Shall handle official general communication among Council members.

C. Shall archive all minutes, historical records, as well as all important documents.

D. Shall assume other duties as determined by the President.

Section 5: The Treasurer.

A. Shall keep financial records and pay all bills.

B. Shall prepare and submit quarterly financial status reports to the BOD.

C. Shall serve as the registrar for all conferences and workshops.

D. Shall archive all financial records.

E. Shall act as second signer on contracts as needed.

F. Shall be a voting member of the Finance Committee.

G. Shall assume other duties as determined by the President.

Section 6: Membership Director

A. Shall serve as Membership Committee Chair. The committee will consist of the Regional Coordinators.

B. Shall assist in the creation and promotion of membership campaigns, and promotes active participation in all meetings and activities.

Section 7: Division Director

A. Shall serve as Division Committee Chair. The committee will consist of all the Division Representatives.

B. It shall be the duty of the Division Director to serve on the BOD to represent the Division Representatives and to develop the program including professional development, conference events and other professional activities.

B. Shall unify and enrich communication among acting and retired educators within the state.

Article II – Duties of the Board of Directors and Standing Committees.

It shall be the responsibility of all BOD members to provide their successors with all records and correspondence related to the position. It shall be the responsibility of all BOD members to provide a written quarterly report to the BOD.

Section 1: Board of Directors

The BOD shall have authority to represent and so act for the Association in the interim between meetings of that body, except where noted. The BOD shall serve as the executive authority of the NMAEA. It shall suggest policies for consideration at annual meetings, carry out policies, and provide such supervision as may be necessary to promote the best interests of the NMAEA's goals and programs.

It shall approve all expenditures and present a financial report to the membership.

Section 2: Advisory Council

The Advisory Council is made up of appointed members in good standing to be the Communications Chair, the Conference Chair, the Scholastic Art Chair, the Awards Chair, the Resource Development Chair, the Youth Art Month Chair and the Equity

Diversity and Inclusion Chair. Committee Chairs shall be appointed by the BOD and each appointment will be reviewed annually. They will serve as the chair of the Standing Committees. The Advisory Council also includes the State Department Visual Arts Advisor. The Advisory Council:

- A. Shall attend quarterly Council meetings.
- B. Shall report on their committee activity monthly.
- C. Shall chair committee meetings.
- D. Shall act in an advisory role at Council meetings.
- E. Shall appoint committee members who are Association members in good standing.
- F. Shall recommend to the BOD replacing committee members that are not fulfilling duties.

Section 3: Standing Committees:

A. Resource Development Committee. The Resource Development Committee shall develop guidelines for the promotion of art education throughout New Mexico. The Chairperson of the Resource Development Committee has the authority to appoint committee members.

B. Awards Committee. The Awards Committee shall be responsible for the awards program for the association. The Chairperson of the Awards Committee has the authority to appoint committee members.

C. Communications Committee. The Communications Committee shall be responsible for the digital and print media for the association. The Chairperson of the Communications Committee has the authority to appoint committee members.

D. Conference Committee. The Conference Committee shall be responsible for the development and planning of all conferences. The Chairperson of the Conference Committee has the authority to appoint committee members.

E. Finance Committee. The Finance Committee shall develop a budget for the NMAEA. The Finance Committee will develop plans to increase revenue for the NMAEA. The Chairperson of the Finance Committee shall be the Treasurer. The Finance Chair has the authority to appoint one Advisory Council member and one

Member at Large as committee members with the approval of the BOD. The Finance Chair shall submit any legal financial reports as required, arrange for audit of association books once a year by a CPA, and submit quarterly and annual financial status reports to the BOD. The Current Past-President shall be an active voting member of the committee.

F. Membership Committee. The Membership Committee shall be responsible for the creation and promotion of membership campaigns. The Chairperson of the Membership Committee has the authority to appoint committee members. The Membership Committee shall include a Regional Coordinator from each of region, who shall be appointed by the Chairperson.

G. Scholastic Art Committee. The Scholastic Art Committee shall be responsible for the development and planning of the New Mexico Scholastic Arts Program. The Chairperson of the Scholastic Art Committee has the authority to appoint committee members.

H. Youth Art Month Committee. The Youth Art Month (YAM) Committee shall be responsible for the flag contest and working in partnership with the State Department Visual Arts Advisor to honor quality artwork by students throughout the state.. The Youth Art Month Committee Chairperson has the authority to appoint committee members.

I. Divisions Committee. The Divisions Committee shall be responsible for communicating with members and non-members in their division and providing division-appropriate resources and representation. The Divisions Committee shall include Division Representatives and the Chairperson has the authority to appoint committee members with approval of the BOD.

J. Equity, Diversity, & Inclusion (EDI) Committee. The Equity, Diversity, & Inclusion Committee shall be responsible for examining the philosophies and practices of the organization, for evaluating the equity of their impact, and for supporting equitable outcomes for the organization. The committee's work is to be based on information and advisement from the National Art Education Association and other evidence-based sources, providing information, analysis, purpose, and

strategies for organizational and educational improvement. The Chairperson of the Equity, Diversity, and Inclusion Committee shall have the authority to appoint committee members with the approval of the BOD.

Article III – Membership and Dues

Section 1: Amount of Dues.

The dues for all classes of membership in the NMAEA shall be determined by the States Assembly of the NAEA.

Section 2: Classes of Membership.

Unless otherwise specified, all classes of membership are for a period of one year. The following classes of membership are established:

A. Active: For art teachers, directors of art education programs, or those engaged in pursuits closely related to the field. Affords you all of the benefits of membership.

B. First Year Professional: For recent graduates entering their first year of teaching art. Valid for one year only. Affords you all of the benefits of membership except the right to hold national office.

C. Student: For undergraduates and full-time graduate students. Affords you all of the benefits of membership except the right to hold national office.

D. Retired: For retirees who have been a member of NAEA for a minimum of five years. Affords you all of the benefits of membership.

E. Associate Non-Art Educator: For school personnel not actively engaged in the teaching of art and for all those interested in art education. Provides most benefits, except the right to vote, and hold national office.

F. Institutional/ School-Based Partnerships: For institutions or departments involved with art education. One individual is appointed the designated contact and will receive all of the benefits of membership, except the right to vote and hold office. Includes a complimentary subscription to Studies in Art Education, one pre-paid national convention registration, and eligibility for NAHS sponsorship where appropriate.

G. Honorary. Honorary memberships may be conferred upon persons who have made some outstanding contributions to art education and whose names have been approved by the BOD and the Regional Unit Assembly of NAEA. This membership is conferred for the life of the member.

Article IV – Adoption of Constitution and Bylaws

After presentation of the proposals for reorganization to the membership, and upon a simple majority approval of the votes cast from the current NMAEA members voting, this Constitution and Bylaws becomes operative immediately.

Article V – Manual of Policies and Procedures

The NMAEA BOD shall adopt and publish policies which govern the procedures of the Association. Material shall be reviewed biennially by newly elected BOD members. Changes shall be made as deemed necessary.

Article VI – Fiscal and Administrative Year

The fiscal and administrative year shall extend from January 1st to December 31st.

Article VII – Rules of Order

Robert's Rules of Order (revised) shall be authority on all questions of procedure not otherwise covered in the Constitution and Bylaws. The President shall appoint the Parliamentarian when necessary.

Article VIII: Amendments.

The Bylaws may be amended by a simple majority vote of the BOD, provided that a proposed amendment has been previously approved by the NMAEA BOD at a regular NMAEA BOD meeting, and that copies have been sent to all members of the BOD 30 days in advance of the meeting.
